



#### Heaps' law




Vocabulary size M as a function of collection size T (number of tokens) for Reuters-RCV1. For these data, the dashed line  $\log_{10} M = 0.49 * \log_{10} T + 1.64$  is the best least squares fit. Thus,  $M = 10^{1.64} \, T^{0.49}$  and  $k = 10^{1.64} \approx 44$  and b = 0.49.

## Zipf's law



 $cf_i \propto \frac{1}{i}$  The most frequent term (the) occurs  $cf_1$  times, the second most frequent term (of) occurs  $cf_2 = \frac{1}{2}cf_1$  times, the third most frequent term (and) occurs  $cf_3 = \frac{1}{3}cf_1$  times etc.

## Variable byte (VB) code

- Dedicate 1 bit (high bit) to be a continuation bit c.
- If the gap G fits within 7 bits, binary-encode it in the 7 available bits and set c = 1.
- Else: set c = 0, encode high-order 7 bits and then use one or more additional bytes to encode the lower order bits using the same algorithm.

## Gamma codes for gap encoding

- Represent a gap G as a pair of length and offset.
- Offset is the gap in binary, with the leading bit chopped off.
- Length is the length of offset.
- Encode length in unary code
- The Gamma code is the concatenation of length and offset.

#### Ranked retrieval

- Thus far, our queries have been Boolean.
  - Documents either match or don't.
- Good for expert users with precise understanding of their needs and of the collection.
- Also good for applications: Applications can easily consume 1000s of results.
- Not good for the majority of users
- Most users are not capable of writing Boolean queries . . .
  - ... or they are, but they think it's too much work.
- Most users don't want to wade through 1000s of results.
- This is particularly true of web search.

#### Problem with Boolean search: Feast or famine

- Boolean queries often result in either too few (=0) or too many (1000s) results.
- Query 1 (boolean conjunction): [standard user dlink 650]
  - $\bullet \rightarrow 200,000 \text{ hits feast}$
- Query 2 (boolean conjunction): [standard user dlink 650 no card found]
  - $\bullet \to 0$  hits famine
- In Boolean retrieval, it takes a lot of skill to come up with a query that produces a manageable number of hits.

#### Feast or famine: No problem in ranked retrieval

- With ranking, large result sets are not an issue.
- Just show the top 10 results
- Doesn't overwhelm the user
- Premise: the ranking algorithm works: More relevant results are ranked higher than less relevant results.

## Scoring as the basis of ranked retrieval

- How can we accomplish a relevance ranking of the documents with respect to a query?
- Assign a score to each query-document pair, say in [0,1].
- This score measures how well document and query "match".
- Sort documents according to scores

#### Query-document matching scores

- How do we compute the score of a query-document pair?
- If no query term occurs in the document: score should be 0.
- The more frequent a query term in the document, the higher the score
- The more query terms occur in the document, the higher the score
- We will look at a number of alternatives for doing this.

#### Take 1: Jaccard coefficient

- A commonly used measure of overlap of two sets
- Let A and B be two sets
- Jaccard coefficient:

$$JACCARD(A, B) = \frac{|A \cap B|}{|A \cup B|}$$

$$(A \neq \emptyset \text{ or } B \neq \emptyset)$$

- JACCARD(A, A) = 1
- JACCARD(A, B) = 0 if  $A \cap B = 0$
- A and B don't have to be the same size.
- Always assigns a number between 0 and 1.

#### Jaccard coefficient: Example

- What is the query-document match score that the Jaccard coefficient computes for:
  - Query: "ides of March"
  - Document "Caesar died in March"
  - JACCARD(q, d) = 1/6

## What's wrong with Jaccard?

- It doesn't consider term frequency (how many occurrences a term has).
- Rare terms are more informative than frequent terms. Jaccard does not consider this information.
- We need a more sophisticated way of normalizing for the length of a document.
- Later in this lecture, we'll use  $|A \cap B|/\sqrt{|A \cup B|}$  (cosine) . . .
- ...instead of  $|A \cap B|/|A \cup B|$  (Jaccard) for length normalization.

#### Bag of words model

- We do not consider the order of words in a document.
- John is quicker than Mary and Mary is quicker than John are represented the same way.
- This is called a bag of words model.
- In a sense, this is a step back: The positional index was able to distinguish these two documents.
- We will look at "recovering" positional information later in this course.
- For now: bag of words model

#### Term frequency tf

- The term frequency tf<sub>t,d</sub> of term t in document d is defined as the number of times that t occurs in d.
- We want to use tf when computing query-document match scores.
- But how?
- Raw term frequency is not what we want because:
- A document with tf = 10 occurrences of the term is more relevant than a document with tf = 1 occurrence of the term.
- But not 10 times more relevant.
- Relevance does not increase proportionally with term frequency.

## Instead of raw frequency: Log frequency weighting

• The log frequency weight of term t in d is defined as follows

$$\mathbf{w}_{t,d} = \left\{ \begin{array}{ll} 1 + \log_{10} \mathsf{tf}_{t,d} & \mathsf{if} \; \mathsf{tf}_{t,d} > 0 \\ 0 & \mathsf{otherwise} \end{array} \right.$$

- $\mathsf{tf}_{t,d} o \mathsf{w}_{t,d}$ :  $0 o 0, \ 1 o 1, \ 2 o 1.3, \ 10 o 2, \ 1000 o 4, \ \mathsf{etc.}$
- Score for a document-query pair: sum over terms t in both q and d:  $\mathsf{tf-matching\text{-}score}(q,d) = \sum_{t \in q \cap d} (1 + \log \mathsf{tf}_{t,d})$
- The score is 0 if none of the query terms is present in the document.

#### Exercise

- Compute the Jaccard matching score and the tf matching score for the following query-document pairs.
- q: [information on cars] d: "all you've ever wanted to know about cars"
- q: [information on cars] d: "information on trucks, information on planes, information on trains"
- q: [red cars and red trucks] d: "cops stop red cars more often"

## Frequency in document vs. frequency in collection

- In addition, to term frequency (the frequency of the term in the document) ...
- ... we also want to use the frequency of the term in the collection for weighting and ranking.

#### Desired weight for rare terms

- Rare terms are more informative than frequent terms.
- Consider a term in the query that is rare in the collection (e.g., ARACHNOCENTRIC).
- A document containing this term is very likely to be relevant.
- → We want high weights for rare terms like ARACHNOCENTRIC.

#### Desired weight for frequent terms

- Frequent terms are less informative than rare terms.
- Consider a term in the query that is frequent in the collection (e.g., GOOD, INCREASE, LINE).
- A document containing this term is more likely to be relevant than a document that doesn't . . .
- ... but words like GOOD, INCREASE and LINE are not sure indicators of relevance.
- ullet For frequent terms like GOOD, INCREASE, and LINE, we want positive weights ...
- ... but lower weights than for rare terms.

#### Document frequency

- We want high weights for rare terms like ARACHNOCENTRIC.
- We want low (positive) weights for frequent words like GOOD, INCREASE, and LINE.
- We will use document frequency to factor this into computing the matching score.
- The document frequency is the number of documents in the collection that the term occurs in.

## idf weight

- df<sub>t</sub> is the document frequency, the number of documents that t occurs in.
- $df_t$  is an inverse measure of the informativeness of term t.
- We define the idf weight of term t as follows:

$$\mathsf{idf}_t = \mathsf{log}_{10} \, \frac{\mathsf{N}}{\mathsf{df}_t}$$

(N is the number of documents in the collection.)

- idf<sub>t</sub> is a measure of the informativeness of the term.
- $[\log N/\mathrm{df}_t]$  instead of  $[N/\mathrm{df}_t]$  to "dampen" the effect of idf
- Note that we use the log transformation for both term frequency and document frequency.

#### Examples for idf

Compute  $\mathrm{idf}_t$  using the formula:  $\mathrm{idf}_t = \log_{10} \frac{1,000,000}{\mathrm{df}_t}$ 

term	$df_t$	$idf_t$
calpurnia	1	6
animal	100	4
sunday	1000	3
fly	10,000	2
under	100,000	1
the	1,000,000	0

## Effect of idf on ranking

- idf affects the ranking of documents for queries with at least two terms.
- For example, in the query "arachnocentric line", idf weighting increases the relative weight of ARACHNOCENTRIC and decreases the relative weight of LINE.
- idf has little effect on ranking for one-term queries.

# Collection frequency vs. Document frequency

word	collection frequency	document frequency
INSURANCE	10440	3997
TRY	10422	8760

- Collection frequency of t: number of tokens of t in the collection
- Document frequency of t: number of documents t occurs in
- Why these numbers?
- Which word is a better search term (and should get a higher weight)?
- This example suggests that df (and idf) is better for weighting than cf (and "icf").

# tf-idf weighting

 The tf-idf weight of a term is the product of its tf weight and its idf weight.

$$w_{t,d} = (1 + \log \mathsf{tf}_{t,d}) \cdot \log rac{\mathit{N}}{\mathsf{df}_t}$$

- tf-weight
- idf-weight
- Best known weighting scheme in information retrieval
- Alternative names: tf.idf, tf x idf

# Summary: tf-idf

- Assign a tf-idf weight for each term t in each document d:  $w_{t,d} = (1 + \log \mathsf{tf}_{t,d}) \cdot \log \frac{N}{\mathsf{df}_t}$
- The tf-idf weight ...
  - ...increases with the number of occurrences within a document. (term frequency)
  - ...increases with the rarity of the term in the collection. (inverse document frequency)

#### Documents as vectors

- Each document is now represented as a real-valued vector of tf-idf weights  $\in \mathbb{R}^{|V|}$ .
- So we have a |V|-dimensional real-valued vector space.
- Terms are axes of the space.
- Documents are points or vectors in this space.
- Very high-dimensional: tens of millions of dimensions when you apply this to web search engines
- Each vector is very sparse most entries are zero.


#### Queries as vectors

- Key idea 1: do the same for queries: represent them as vectors in the high-dimensional space
- Key idea 2: Rank documents according to their proximity to the query
- proximity = similarity
- proximity ≈ negative distance
- Recall: We're doing this because we want to get away from the you're-either-in-or-out, feast-or-famine Boolean model.
- Instead: rank relevant documents higher than nonrelevant documents

# How do we formalize vector space similarity?

- First cut: (negative) distance between two points
- ( = distance between the end points of the two vectors)
- Euclidean distance?
- Euclidean distance is a bad idea . . .
- ... because Euclidean distance is large for vectors of different lengths.

# Why distance is a bad idea



 $\vec{q}$  and  $\vec{d}_2$  is large although the distribution of terms in the query q and the distribution of terms in the document  $d_2$  are very similar. Questions about basic vector space setup?


## Use angle instead of distance

- Rank documents according to angle with query
- Thought experiment: take a document d and append it to itself. Call this document d'. d' is twice as long as d.
- "Semantically" d and d' have the same content.
- The angle between the two documents is 0, corresponding to maximal similarity . . .
- ... even though the Euclidean distance between the two documents can be quite large.

## From angles to cosines

- The following two notions are equivalent.
  - Rank documents according to the angle between query and document in decreasing order
  - Rank documents according to cosine(query,document) in increasing order
- $\bullet$  Cosine is a monotonically decreasing function of the angle for the interval  $\left[0^{\circ},180^{\circ}\right]$

## Cosine



## Length normalization

- How do we compute the cosine?
- A vector can be (length-) normalized by dividing each of its components by its length here we use the  $L_2$  norm:  $||x||_2 = \sqrt{\sum_i x_i^2}$
- This maps vectors onto the unit sphere ...
- ... since after normalization:  $||x||_2 = \sqrt{\sum_i x_i^2} = 1.0$
- As a result, longer documents and shorter documents have weights of the same order of magnitude.
- Effect on the two documents d and d' (d appended to itself) from earlier slide: they have identical vectors after length-normalization.

# Cosine similarity between query and document


$$\cos(\vec{q}, \vec{d}) = \text{SIM}(\vec{q}, \vec{d}) = \frac{\vec{q} \cdot \vec{d}}{|\vec{q}||\vec{d}|} = \frac{\sum_{i=1}^{|V|} q_i d_i}{\sqrt{\sum_{i=1}^{|V|} q_i^2} \sqrt{\sum_{i=1}^{|V|} d_i^2}}$$

- $q_i$  is the tf-idf weight of term i in the query.
- $d_i$  is the tf-idf weight of term i in the document.
- $|\vec{q}|$  and  $|\vec{d}|$  are the lengths of  $\vec{q}$  and  $\vec{d}$ .
- This is the cosine similarity of  $\vec{q}$  and  $\vec{d}$  .....or, equivalently, the cosine of the angle between  $\vec{q}$  and  $\vec{d}$ .

#### Cosine for normalized vectors

- For normalized vectors, the cosine is equivalent to the dot product or scalar product.
- $\cos(\vec{q}, \vec{d}) = \vec{q} \cdot \vec{d} = \sum_i q_i \cdot d_i$ 
  - (if  $\vec{q}$  and  $\vec{d}$  are length-normalized).

## tf-idf example

- We often use different weightings for queries and documents.
- Notation: ddd.qqq
- Example: Inc.ltn
- document: logarithmic tf, no df weighting, cosine normalization
- query: logarithmic tf, idf, no normalization
- Isn't it bad to not idf-weight the document?
- Example query: "best car insurance"
- Example document: "car insurance auto insurance"

# Summary: Ranked retrieval in the vector space model

- Represent the query as a weighted tf-idf vector
- Represent each document as a weighted tf-idf vector
- Compute the cosine similarity between the query vector and each document vector
- Rank documents with respect to the query
- Return the top K (e.g., K=10) to the user
